**EXPRESS & OVERNIGHT MAIL: MUST BE SENT "NO SIGNATURE REQUIRED"**

**USE ONLY OFFICIAL AKC ENTRY FORMS** (photocopies of entry blanks without the Agreement and Rules on the reverse side of form will not be accepted).

**ANY ENTRY BLANKS WITHOUT COMPLETE INFORMATION, NOT SIGNED OR ACCOMPANIED BY FEES WILL NOT BE ACCEPTED.**

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$25.00 to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a cash only basis.

**ENTRY FEES** will not be refunded in the event of errors or cancellations of entries after the published closing date, nor in the event that a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

**NO ENTRY** shall be accepted which specifies any condition as to its acceptance.

**NO DOGS** wrongly entered in a class may be transferred to another class, except as provided for in Chapter 11, Section 6 of the AKC Rules Applying To Dog Shows.

**MOVE UPS** Must be made 30 Minutes before start of Judging.

**OWNERS AND HANDLERS ARE RESPONSIBLE** for errors in entry forms, and entering the same dog twice, regardless of who may make such errors or duplicate entries.

**NEW CHAMPIONS** Any dog that finishes its championship according to the owners records may be transferred up to 30 minutes before the start of judging.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

Schools are located on and within close proximity of the RV Park. Therefore please be advised that in accordance with section 3003 (G) of the California Penal code: "Notwithstanding any other law, an inmate who is released on parole for a violation of Section 288 or 288.5 whom the Department of Corrections and Rehabilitation determines poses a high risk to the public shall not be placed or reside, for the duration of the inmate's parole, within one-half mile of a public or private school including any or all of kindergarten and grades 1 to 12, inclusive." People falling within this definition are not eligible to rent an RV/trailer space due to the location of the schools falling within the one-half mile restriction.

**RULES & REGULATIONS**

1. Do not enter the Association fairgrounds if you are showing signs of sickness such as cough or fever.
2. Due to COVID-19 we ask that all guests staying on the Association fairgrounds observe the safety guidelines and as prescribed by the California Department of Public health; wear a mask when coming to the office/camp host or going indoors.
3. RV/Trailer space fees (\$40 per night) are paid in advance. (2 week maximum stay).  
 In the event of a natural disaster/war/civil disobedience/pandemic or other requirement by the government; the grounds may be required/ordered by a federal/state/county or city agency requiring use or closing of the facility. In the event of cancellation of the agreement Association is not liable for any loss or expenses that may occur to the renter due to such an emergency/declaration.
4. Driver, RV, Trailer & Vehicle (one only) require proof of current license & insurance.
5. RV's & Trailers must have properly functioning holding tanks and flex waste disposal lines.
6. RV's & Trailers are clean and have fully operational windows & doors (including locks).
7. RV's & Trailers electrical systems must be safe and well maintained. Modifying electrical outlets is not allowed.
8. All vehicles must be capable of moving immediately.
9. No open fires/fire pits/wood or charcoal barbecues are permitted. Only gas barbecues may be used in the Association fairgrounds RV Park.
10. Vehicle/RV/Trailer maintenance is never to be performed on District property.
11. Vehicle/RV/Trailer washing is not allowed on District property.
12. Weapons are not allowed on District property.
13. Noise and visitors are kept to a minimum at all times. Noise and visitors are not allowed on District property after 10:00 PM. Vehicles will be parked in designated parking areas.
14. Everyone needs to be considerate of their neighbors at all times.

15. Dogs are allowed on District property but must be registered in the office. All pets must be leashed at all times when outside of site. Dogs cannot be off leash unless you have a dog pen that's appropriate to the dog's size at your site. You must be in your rig or on your site to do this. Dogs cannot be left tied up at your site. No dog is to be left outside overnight. Please be courteous to others and do not leave the dog in the rig or outside for an extended period of time if it barks when left alone. All dogs must have a current rabies vaccination and health certificate. The owner is fully responsible and is required to clean up after their dog. The owner is responsible for any damage to District property or the property to others as well as, any injuries caused by your pet to a person(s) or another animal(s).
16. RV & Trailer occupancy is limited to manufactures occupancy specifications.
17. Vehicles (s) & campsite are maintained in a safe, sanitary and orderly manner. Children are to remain in the vicinity of their own trailer. For their safety, they are not allowed out of the trailer area.
18. Failure of Association to insist in any one or more instances upon the observance and or performance of any of these rules and regulations shall not constitute a waiver of any subsequent breach of any such rules and regulations.
19. The 36<sup>th</sup> District Agricultural Association reserves the right to immediately remove any person and/or vehicle from the Association's property.
20. Rentor agrees to indemnify and save harmless Association and the State of California, their officers, agents, servants and employees from any and all claims, causes of action and suits accruing or resulting from any damage, injury or loss to any person or persons, including all persons to whom the renter may be liable under any worker's Compensation law and Rentor himself and from loss, damage, cause of action, claims or suits for damages, including but not limited to loss of property, goods, wares or merchandise, cause by, arising out of or in any way connected with the exercise by Rentor of the privileges herein granted.
21. It is mutually agreed that this agreement (contract) or the privileges granted herein, or any part thereof, cannot be assigned or otherwise disposed of without the written consent of the Association.
22. It is mutually understood and agreed that no alteration or variation of the terms of this agreement shall be valid, unless made in writing and signed by the parties hereto, and that no oral understanding or agreements not incorporated herein and no alterations or variations of the terms hereof, unless made in writing and signed by the parties hereto, shall be binding upon any of the parties hereto.
23. The Rules and Regulations printed on this side and the reverse side hereof are made a part of this agreement as though fully incorporated herein, and Rentor agrees that he has read this agreement and the said Rules and Regulations and understands that they shall apply, unless amended by mutual consent in writing of the parties hereto.
24. In the event Rentor fails to comply in any respect with the terms of this agreement and the Rules and Regulations referred to herein, all payments for this rental space shall be deemed earned and non-refundable by Association and Association shall have the right to occupy the space in any manner deemed for the best interests of Association.

It is understood in the event of a Rentor's failure to vacate said premises as herein provided, unless permission in writing is first obtained, Association may and is hereby authorized and made the agent of Rentor to remove and store the recreational vehicle, trailer, vehicle, truck and all other material of any nature whatsoever, at Rentor's risk and expense, and Rentor shall reimburse Association for expenses thus incurred.

**THE WELFARE OF AN EXHIBITOR'S CHILD** is to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.

**DO NOT LEAVE DOGS IN CLOSED VEHICLES.** Any unsupervised dog in distress may be removed from a vehicle by whatever means if necessary. By entering this show the owner, exhibitor or handler agrees to hold harmless and indemnify both SSCNC, INC & SVSSC or it's members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
